Filing and Payment Instructions

Payment can be made by cash or personal check made out to "Manassas City Republican Committee" and enclosed along with this filing form. It must be mailed to 8665 Sudley Road #224 Manassas, VA 20110 and received by Wednesday March, 11th, 2026 or delivered in person at the 6:30 PM GOP Committee Meeting on Wednesday March, 11th, 2026 at the Old Towne Sports Pub, 8971 Center St, Manassas, VA 20110 (post marks do not govern).

Campaign Finance and Tax Disclosures

By making a contribution/paying a fee you are attesting that you are a citizen of the United States and that funds are your own. VA state law requires us to report the name, mailing address, occupation and name of employer for all contributions. Contributions are not tax deductible for Federal or State income tax purposes.

Manassas Canvass Information

Manassas City may elect up to 225 Delegates and an equal number of Alternates to the 2026 10th District Convention at the Manassas City canvass. Also, up to 150 members at-large may be elected as members to the Manassas City Republican Committee. Lastly, the position of chair of the Manassas GOP committee shall be elected.

If fewer than the maximum number file for any specific position, all verified filers will be elected automatically. If a greater number should file for any specific position, a party canvass (election) open to all Manassas City registered voters who attest to the principals of the Republican Party will be held on Saturday March, 28th, 2026, from 10 a.m. to 2 p.m., at Manassas GOP HQ, located at 9016 Center Street Manassas, VA 20110. The candidates receiving the most votes will be elected. The time and place of the canvass may be changed as warranted; updated information will be available online at www.manassascitygop.com.

10th District Convention Information

The 2026 10th District convention will be held on April 18th, 2026, at 10:00 am at a location to be announced at a future date. Future communication will occur regarding event location and other details when available.

Candidates for Manassas GOP Chair

Any candidate wishing to run for the position of Manassas City Committee Chair, in addition to filling out this form to apply to become a committee member, must also indicate in writing their intent to seek this office by Wednesday March, 11th, 2026 along with an additional filing fee of \$500 made out to "Manassas City Republican Committee". Filing fee is non-refundable. Please refer to the party Canvass Call for additional detail.

Military Members as District Convention Delegates

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) who comply with these filing requirements shall not be required to be elected but shall be declared delegates to the 10th Congressional District Convention pursuant to Article VIII, Section H. of the Plan of Organization of the Republican Party of Virginia. Military Member delegates or alternate delegates that are unable to attend the 10th Congressional District Convention and/or RPV Convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots. Instructions regarding the casting of candidate preference ballots will be available in the Calls for the Conventions, which are available on the website of the RPV. There are no Military Member absentee voting provisions for the Manassas City Republican Committee Chairman Party Canvass.
